Notice of 2024 Vestry & Delegate Nominations

Our Annual Meeting will be held after Holy Eucharist on Sunday, January 28.

Vestry Nominations

The vestry is our Parish board. It is responsible for the temporal realities of the parish (such as stewardship of the finances and care of the buildings) and also serves in an advisory role to the priest. At the Annual Meeting, the Vestry terms of four members will conclude: Barbara Cortese, Bruce Curtis, Barbara Vasko, Linda Reiff. Members with one year remaining will be Nan Gravel & Roz Taulbee. Members with two years remaining will be Josette Adams, Justin Black, & Larry Johnson.

The requirement of Diocesan Canons is that "each congregation shall provide for the rotation in office of the Vestry members, in such manner that at least one new member shall be chosen each year and that no vestry member shall be eligible for immediate reelection." At the upcoming Annual Meeting, **three** members will be added to the Vestry. This will reduce the vestry membership from nine lay people to eight for one year. However, this will regularize the election of three members each year, which will allow us to return to a nine member vestry in 2025, when only two members roll off.

In order to be nominated to stand for election to Vestry, Diocesan canons require that one must be a <u>confirmed communicant in good standing</u> and <u>must have fulfilled this requirement for at least ninety days prior to election according to St Matthias' parish bylaws must fulfill the following requirements: "(a) a baptized person in good standing with Saint Matthias Anglican Church; (b) whose name is enrolled in the register of the church; (c) who is a communicant who regularly participates in worship services at the church; (d) who is a faithful financial contributor of record to Saint Matthias Anglican Church; (e) who is at least 18 years of age; and, (f) who has satisfied the foregoing requirements for at least ninety (90) days prior to the date of an election." (8.4.2)</u>

. Vestry members are required to attend as many as two meetings per month (although typically just one) at a customary meeting time determined by that year's Vestry that is convenient for all members.

The nomination period begins December 3. We invite parishioners to prayerfully consider whether God might be calling them to nominate anyone who fits the requirements above. In order to make a nomination, please visit <u>saintmatthiasoakdale.com/nomination</u> or complete the applicable portion of the form below and place it in the offering plate.² Once it is determined that the nominee meets all qualifications, they will be asked by Fr John or a Vestry member whether they accept the nomination. The nomination period will close Wednesday, January 3 and, to ensure proper vetting, there will be no nominations accepted from the floor at the Annual Meeting.

Those <u>not</u> eligible to be nominated for Vestry this year include those who will be completing a full 3-year term and the spouses of Vestry members continuing into 2023.

Lay Delegate Nominations

At our Annual Meeting, we will also elect delegates to represent our parish at the next Diocesan Convention, being held in Visalia on October 24-25, 2024. Saint Matthias will send two delegates to Convention, along with all our clergy, and have two alternates. Being a delegate is a tremendous responsibility, but also a great opportunity to get to know the Anglican Church and tradition on the Diocesan level. Lay Delegates are required to be communicants in good standing. We invite parishioners to prayerfully consider whether God might be calling them to nominate anyone who fits this requirement. In order to make a nomination, please visit saintmatthiasoakdale.com/nomination or complete the applicable portion of the form below and place it in the offering plate. Once it is determined that the Nominee meets the qualifications, they will be asked by Fr John or the Vestry whether they accept the nomination. The nomination period will close Wednesday, January 3.
